

- BITCHES IN SEASON ARE NOT ALLOWED ON THE TEST GROUNDS.
- Entry fees for bitches that come into season after the closing date will be refunded (minus a \$6 administration fee) if a veterinarian's certificate is presented to the Test Secretary prior to the start of judging.
- A limited number of dogs may be entered the day of the test if space and birds are available. Additional fee of \$5.00 for dogs entered after closing on the day of the test.
- The WCX land series will start at 8 am
- The WC land series will follow the WCX land series

#### **Directions to Greenleaf's:**

Traveling on I-405 north of Bellevue: Take exit 23 toward US-

2/Woodenville/Wenatchee. Take US-2/Stevens Pass Hwy toward Wenatchee. Turn right onto N Lewis St/ WA-203. Go about 1.2 miles, and turn right on gravel driveway before white house.

#### NOTICE TO EXHIBITORS

#### SAFETY. BEHAVIOR and LIABILITY

The safety of the handler and the dog is our primary concern. By entering this test, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are accustomed to gunshot and live birds.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the test committee, be asked to leave the test site. In such case, no refund of any fees paid will be made. IWSCOPS and its agents, employees, etc., will assume no responsibilities for any loss, damage, or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

IWSCOPS reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the IWSCOPs or any official thereof.

All dogs must be on leash at all times when on test grounds except the dog being tested. No pinch/prong, electric, or special training collars are allowed on the test grounds.

Parking is along the gravel roads on the property; at no time is driving in the fields permitted.

#### **REFUNDS**

No entry fee will be refunded if the test cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Test Committee.

Bitches in season are not permitted on the grounds and are not permitted to compete in the test. As such, the club will refund all but \$6 of the entry fee paid for bitches unable to compete for this reason upon presentation of a veterinarian certificate. This certificate must be presented to the Test Secretary prior to the start of judging.

Handlers and dogs may arrive any time after 7 a.m. and prior to start of the test.

Judges are not required to wait for dogs. The Exhibitor of each dog is solely responsible for having it ready when their number is called. The Club has no responsibility for providing service through a public address system or runners for the purpose of calling or locating dogs that are not brought to the line when required.
